### **Message from the Board Chair**



Dear SCI partners, supporters and friends,

The year we left behind was a year of great developments and challenges for Albania, our region, and the

world. The country's political life was shaken by strong clashes, while a profound justice system reform took important steps towards achieving results. The earthquakes of September 21 and November 26, 2019, led to the loss of lives of 51 fellow citizens. left thousands homeless, and were followed by a massive wave of solidarity by Albanians in the country and abroad helping those that were most affected by the earthquake. Efforts to deepen cooperation among Western Balkan countries continues, as Albania's and Northern Macedonia's aspirations to open EU membership negotiations, as well as the need for Kosovo citizens to move visa-free to the Schengen area faced the skepticism of some European Union member states. Democracy continued to lose ground in many countries around the world, including some European Union member states, while climate change continued to worsen and dominated international public debates. ber states. In this political, economic, and social context, there is a growing need for broad civic engagement and for an

active and effective role of civil society in addressing the challenges and benefiting from the opportunities for positive change that these challenges create.

With this conviction and its dedication to its mission as a civil society organization, the Social Contract Institute (SCI) launched in 2019 a series of important initiatives that contribute to strengthen the rule of law, expand civic participation in decision-making, and enhance gender mainstreaming in the media. During this year, SCI significantly expanded the network of partner organizations at home and abroad, successfully raised the needed funding for the implementation of its initiatives, and took the first steps in providing services and technical assistance to other civil society organizations.

We are pleased to present you here the Annual Report for 2019 that will provide you with detailed information on all SCI initiatives during this successful year for the Institute.

#### Timeframe

#### April 1, 2018 – April 30, 2019

In March 2019, it was accomplished Improved Awarding and Implementation of Alternative Sentences project, which was funded by the Civic Engagement for a Functional Judicial System and Justice Approach in Albania program, an EU-funded program, implemented by Save The Children and CILPS. Through this project, SCI contributed in: (i) improvement of the rate and quality of alternative sentences awarded by the courts and monitored by Probation Services (PbS) offices in Tropoja, Dibra, Kruja (in Northern Albania), and Përmet, Pogradec, Saranda (in Southern Albania) and beyond; and (ii) enhancment opportunities for first-time and low risk offenders to have their rights respected and to reintegrate in society and live a life away from crime, after completing the sentence. Based on: reviewing the legal

framework for alternative sentences: assessment findings by SCI experts of alternative sentences given during 2016 by the courts in the areas where the project was focused; the reports of the Probation Service are submitted to the prosecution for individual cases of offenders serving alternative sentences; finding interviews with key actors; and finding focus groups with offenders suffering or having completed alternative sentences, SCI prepared the Alternative Sentences Report. This report includes: quantitative data on the percentage of alternative sentences given by the courts in the areas where the project was focused compared to the total number of criminal cases handled by these courts in 2016; analysis of best practices and concerns regarding the application of alternative sentences; and recommendations for improving the quantity and quality of court decisions that provide alternative sentences, as well as the implementation of these sentences. In April 2019, SCI presented the findings of the report to a roundtable with representatives of the Albanian justice system. The participants' suggestions were reflected in the final report. This project highlighted some very important issues regarding the law on the Probation Service and generated some new ideas on how civil society can further contribute to this area.

Community Governance: challenges to the functioning of citizens participation mechanisms in Korça district

In April 2019, SCI started the implementation of the project Community Governance: challenges to the functioning of citizens participation mechanisms in Korca district. During this project, SCI identified the potential Change Agents in the six municipalities of Korça region and trained them. SCI signed a memorandum of understanding with the Korça Regional Council to facilitate the communication of Change Agents with the county structures and to ensure the sustainability of the project. SCI also set up the platform http://agientetendryryshimit.com/, which shows the complete map of the Change Agents in the six municipalities of Korça region. Change Agents are active citizens who serve as a focal point in the communities where they live, to convey the problems and suggestions of citizens to local government institutions. They work with these institutions to address the problems of the citizens, thanks to a functional network of local actors who effectively participate in the mechanisms of community governance in the Korça region.

In September 2019, SCI started the implementation of the project Alternative Sentences - Alternatives for a Better Life, funded by MATRA - Rule of Law, program of the Embassy of the Kingdom of the Netherlands in Albania. SCI built the work on this project on the achievements of the project Improved Awarding and Implementation of Alternative Sentences, through which SCI identified some concerns regarding the implementation of the existing legal framework of the Probation Service in Albania. The project aims to improve the implementation and enforcement of alternative sentences in Albania by drafting a practical manual for the implementation of the Probation Service law and training judges and prosecutors (in cooperation with the School of Magistrates), lawyers (in cooperation with the School of Advocacy), and Probation Service employees (in collaboration with the Probation Service Directorate). SCI will also work to increase the capacity of local government representatives, NGOs, police officers, etc., by organizing seminars with them in each district. SCI will prepare and provide all these actors with a reference book (manual) for the implementation of the law on the Probation Service, and will provide them with the knowledge and skills to effectively implement this legal framework.

In February 2019, SCI organized at the Center for Openness and Dialogue (COD) in Tirana the photo exhibition Balkan Girl Power, which concluded the activities of the regional initiative undertaken by five partner organizations: SCI in Albania; National Youth Council of Northern Macedonia (NYCM); iACT in Montenegro; Organization for the Promotion of Activism (OPA) in Serbia; and Artpolis Center - Art and Community from Kosovo. The exhibition was attended by more than 150 invited people and remained open until the end of February 2019. The exhibition closed with the award ceremony for the best photos. After ceremony the girls participating in the exhibition attended a master class with the well-known Albanian-British artist Lala Meredith Vula, who served as artistic director of the entire project. SCI produced 500 calendars for 2019 with the best photos from the participating girls. SCI and other project partners distributed these calendars to the respective countries.

SCI produced 10 podcasts that were distributed through radio and online platforms in a series entitled Talking about Men, and Women focusing on relationships between men and women in Albania, based on real life stories. They tell stories of collaboration between men and women in professional and personal life as good examples to follow in the pursuit of a fairer and more equal society. These podcast series also address hidden gender stereotypes about the concept of family and the relationship between professional and personal life. The project was funded by EVVMI with funding from the British Embassy in Albania.

In September 2019, SCI started the implementation of the project Young Guides, in 7 municipalities of Gjirokastra region. The project will contribute to the enrichment of tourist resources of Gjirokastra through the engagement of young people. SCI selected 25 young men and women, who will be trained to serve as volunteer tourist guides (Young Guides) in the municipalities or villages where they live. During the period October - December 2019, SCI prepared an inventory of tourist resources of Gjirokastra region and, based on these materials, prepared two new tourist itineraries - destinations around the archeological center of Antigone and tourist attractions around the village of Peshtan. SCI will promote Young Guides by disseminating their information in all hotels, restaurants and other tourist spots in Gjirokastra region.

SCI will contribute to create a more favorable environment for youth initiatives in Albania, especially youth initiatives belonging to communities in need or marginalized, through the power of positive models and youth-led initiatives. The project will be implemented in the regions of Tirana, Korca, Gjirokastra, Fier and Durres. SCI will work to equip young people with practical skills that help them live an independent life. SCI will produce 10 video messages from representatives of communities in need or marginalized - poor, returnees, victims of violence, LGBTI people, etc. ,- as a way to motivate young people by telling success stories from people of the same community.



SCI will implement New Green project in Tirana, Shijak and Lushnje. This project will contribute to increase the involvement of young people in the agricultural sector by equipping them with the skills you need to enter the labor market in agriculture. The 50 young men and women selected by SCI will gain a range of skills and knowledge that can help them find employment or selfemployment.SCI will also provide training for these young men and women on how to start a new business in agriculture. 20 of them will have a one-month internship with agricultural businesses, an opportunity to see up close how a business in agriculture works, as well as to get practical advice on how to get involved in the agricultural business as employees or start a business.

## **Other Activities**



During several months, SCI provided technical assistance to the Psycho-Social Center "Vatra" based in Vlora in organizing the celebration of the 20th anniversary of the organization. This activity took place on November 20, 2019 with the participation of high level representatives from central and local government institutions, representatives



of foreign embassies, local NGOs, national and international, etc.

SCI brought the Balkan Girl Power exhibition to Seanema Film Festival in Ulcinj, Montenegro during September 18-22 2019.

In October 2019, SCI contributed to the organization of KazanFest in Këlcyrë, Gjirokastra region, an activity led by the ISO Foundation, renowned artist Boiken Lako and agrotourism Ferma Albanik. During the two days, visitors to this musical and cultural festival enjoyed traditional organic food products of Këlcyra and Përmet and attended concerts by modern music groups from Tirana and folk music groups from Përmet. This festival also served to promote the areas around Këlcyrë as a tourist destination.



## **Organizational Development**


